### 1. Introduction

At WeVote, we are committed to safeguarding your privacy. This Privacy Policy explains the types of personal data we collect, the purposes for which we collect it, and how we handle and protect your information. By using our Website, you consent to the data practices described in this Privacy Policy.

This Privacy Policy is in accordance with Israeli privacy laws, including the **Protection of Privacy Law, 1981**, and Belgian privacy laws, including the **Belgian Data Protection Act of 2018**, which implements the **General Data Protection Regulation (GDPR)**. It also considers global standards such as GDPR and CCPA, ensuring that users' rights are respected at an international level.

### 2. Information We Collect

#### a. Personal Information You Provide Voluntarily

#### b. Information Automatically Collected

We automatically collect certain technical data when you visit our Website, including:

- **Device Information:** IP address, browser type, operating system.
- **Usage Data:** Pages visited, time spent on each page, interactions.
- **Cookies and Tracking Technologies:** Information gathered via cookies and analytics tools.

#### c. Information from Third Parties

We may collect additional information from third-party sources such as public records, social media platforms, and partners.

### 3. How We Use Your Information

We use your personal data for the following purposes:

- **Service Delivery:** Providing, maintaining, and improving our Services.
- **Communication:** Sending updates, newsletters, and relevant notifications.

- **User Experience:** Enhancing your browsing experience with analytics.
- **Security & Fraud Prevention:** Protecting against unauthorized access and potential threats.
- **Compliance:** Meeting legal and regulatory requirements in Israel and Belgium, including obligations under the **Protection of Privacy Law, 1981**, and the **Belgian Data Protection Act of 2018**.

#### 4. Sharing of Information

We do not sell your personal information. However, we may share it in the following circumstances:

- **With Service Providers:** Partners who assist with website hosting, email marketing, and analytics.
- **For Legal Purposes:** When required by Israeli or Belgian law, a court order, or governmental request.
- **With Third-Party Analytics & Advertising Partners:** To improve our reach and engagement.

#### 5. Cookies and Tracking Technologies

We use cookies to enhance your experience on our Website. These cookies help us:

- **Analyze Site Traffic:** Understanding visitor behavior.
- **Remember User Preferences:** Customizing your experience.
- **Serve Targeted Content:** Showing relevant information and advertisements.

In compliance with Israeli and Belgian privacy regulations, users are informed about cookie usage upon accessing the Website and have the ability to manage their preferences.

#### 6. Data Retention & Security

We implement strict security measures to protect your personal data, including:

- **Encryption & Secure Servers:** Protecting stored information.
- **Restricted Access:** Limiting access to authorized personnel only.
- **Regulatory Compliance:** Adhering to GDPR, CCPA, Israeli, and Belgian data protection laws.

Your information will be retained for as long as necessary to fulfill the purposes outlined in this Privacy Policy or as required by Israeli or Belgian law.

- **Right to Data Portability:** Request to receive their personal data in a structured format.
- **Right to Object:** Restrict processing in certain circumstances.
- **Right to Lodge Complaints:** File complaints with the **Belgian Data Protection Authority (APD/GBA)**.
